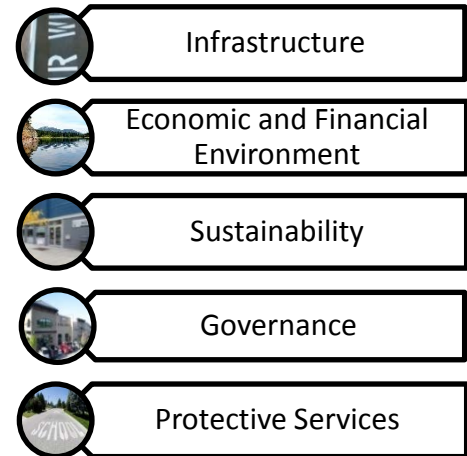
STRATEGIC FOCUS

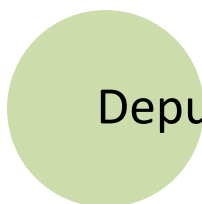
