Local Government Act Section 158 (1) & (2)

BACKGROUND:

Pursuant to Section 158 (1) of the *Local Government Act*, a report of election results must be submitted to the local government within 30 days after the declaration of official election results under section 146 for an election by voting.

The *Act* further requires that for an election by voting, the report must include a compilation of the information on the ballot accounts for the election (Attachment #1).
