NOTICE OF ALTERNATIVE APPROVAL PROCESS (AAP) OPPORTUNITY

The City of West Kelowna wishes to proceed with adoption of Bylaw No. 0313, 2023 being “Fire Hall 32 Loan Authorization Bylaw #0313, 2023”. This bylaw is to authorize the City of West Kelowna to borrow up to eight million dollars (\$8,000,000) of the estimated cost of the construction for the Fire Hall #32 Replacement Project in West Kelowna, B.C. The borrowing amount will be repaid over a period not exceeding 25 years.

Under Section 86 of the Community Charter, if less than 10 per cent of approximately 28,098 (less than 2,810) eligible electors of the City of West Kelowna, object to long-term borrowing, the adoption of the bylaw, the certification process, Council consideration and Certificate of Approval process would occur.

The Elector Response Forms will be available during regular office hours, 8:30 a.m. to 4:30 p.m., Monday through Friday (excluding statutory holidays), at Municipal Hall, 2760 Cameron Road, West Kelowna, B.C. or on the City’s website at westkelownacity.ca/aap.

AAP Elector Response Forms must be completed by eligible electors in the City of West Kelowna who are entitled to sign. Forms will only be accepted if they are in the format established by the City of West Kelowna Council.

If an elector is in favour of the City of West Kelowna borrowing up to eight million dollars (\$8,000,000) of the estimated cost of the construction for the Fire Hall #32 Replacement Project, no action is required.

Regardless of the location from which the form was obtained, the Elector Response Forms must be submitted to the Corporate Officer. Elector Response Forms must be submitted by one of the following options:
