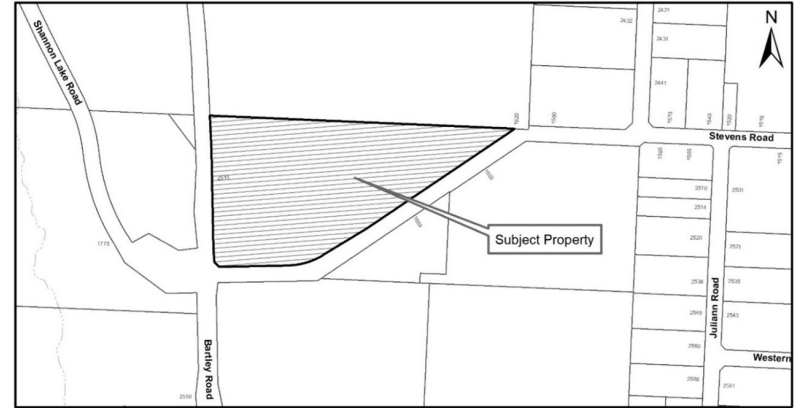

NOTICE OF INTENT TO PROVIDE ASSISTANCE

In accordance with Sections 24, and 94 of the *Community Charter*, the City of West Kelowna gives notice of its intention to enter into a License of Occupation for a ~600m² portion of Bartley Road Right-of-Way and 2515 Bartley Road commencing on July 13, 2024, and terminating on July 13, 2027 for the purpose of operating temporary shelter and supportive services at no cost. In accordance with Section 24 of the *Community Charter*, the City gives notice that it will be providing assistance to BC Housing by allowing the area to be used at no cost, which is less than its' market value.
