#### ZONING AMENDMENT BYLAW NO. 0320.05

**Location:** Throughout the City of West Kelowna

**Purpose:** The City of West Kelowna Council is considering the proposed Zoning Bylaw Amendment No. 0320.05 to expand the City's Short-Term Rental Program and allow Short-Term Rental as a permitted use in secondary suites in the RC3 Zone.
