Purchasers of tax sale properties should be aware that they will not have the right to receive title or possession until after a period of one year has elapsed following the date of sale. During the one year period, the registered owner of the property or the owner of a registered charge may redeem the property thus canceling the sale. In that event, the purchaser would be entitled to receive a refund of the amount paid together with interest to the date of redemption as provided in Section 660 of the Local Government Act. Only cash, certified cheques or bank drafts will be accepted as payments.

The purchase of a tax sale property is subject to tax under the Property Transfer Tax Act on the fair market value of the property.
