NOTICE OF PUBLIC HEARING (A 25-01)

The City of West Kelowna will hold a Public Hearing on **Tuesday, Nov. 25, 2025 at 6 p.m. in Council Chamber at 3731 Old Okanagan Highway, West Kelowna, B.C.** to consider:

Location: Both parcels are located on Gellatly Road, across from the West Kelowna Yacht Club

Legal description: Lot A, DL 487, ODYD, Plan KAP12966 & Lot 3, DL 487, ODYD, Plan KAP316

File number: A 25-01

Purpose: City initiated request to align with the Gellatly Village Study to the Agricultural Land Commission (ALC) for consideration of a land exchange between two parcels. The proposal involves removing 0.45 Ha of Agricultural Land Reserve (ALR) land from the ALR and, in exchange, including an equal amount of non ALR land suited for agriculture into the ALR.

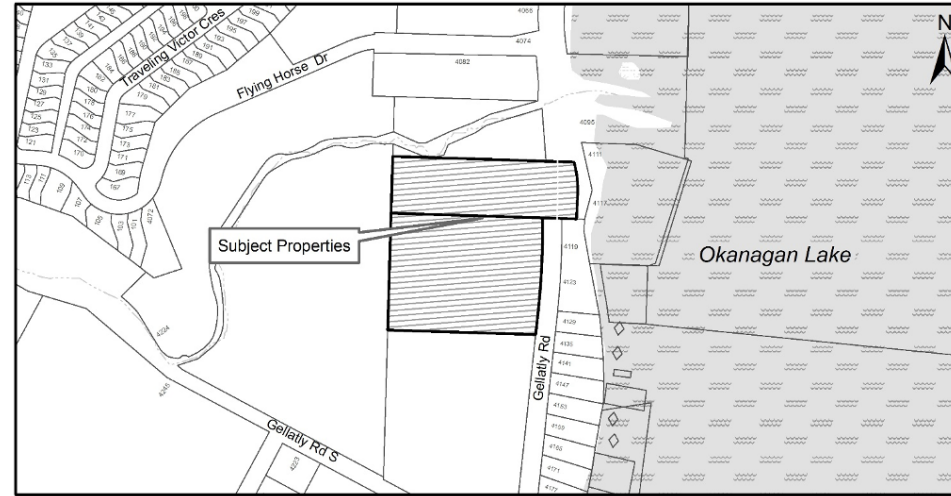
HOW TO MAKE A SUBMISSION
