

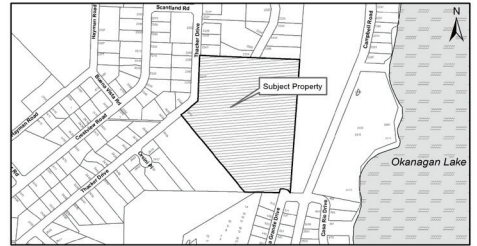


NOTICE OF PUBLIC HEARING Z 18-08

Location: 2377 Thacker Dr.
Legal Description: Lot 108, DL 1118, ODYD, Plan 5381 Except Plan 43347
File No: Z 18-08
Purpose: Amend Official Community Plan Designation and rezone to Single Family Residential (R1) to allow for single family development.

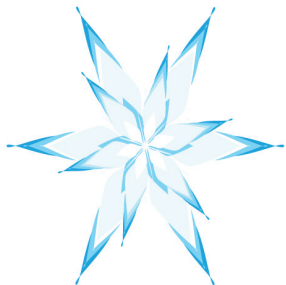
HOW TO MAKE A SUBMISSION

All persons who believe their interest in property is affected by the proposal may either speak at the public hearing or provide a written submission for Council consideration. Written submissions may be delivered in person at Municipal Hall, or mailed or emailed per the contact information given on this notice. All submissions must be made Attn: City Clerk and received before 4:00 p.m. Monday, January 27, 2020. Submissions should reference the file and bylaw numbers in the subject line, and include your name and the civic address or legal description of the land affected by the proposal. Please be advised that all submissions, including authors' names will become part of the public record. Authors' phone numbers and email addresses are not relevant and should not be included in the correspondence if the writer does not wish their personal information disclosed. Written submissions received after the 4:00 p.m. deadline on Monday, January 27, 2020 will not be circulated to Council and are not guaranteed to be read aloud at the Public Hearing. Therefore, the public should attend the Public Hearing to present their submission. Submissions received after the 4:00 p.m. deadline will be available for viewing in the Public Hearing Binder and will form part of the public record. Please note that Council cannot receive submissions after the conclusion of the Public Hearing. For more information contact Chris Oliver, Planner III at 778-797-8830.
