### NOTICE OF HIGHWAY CLOSURE AND DISPOSITION

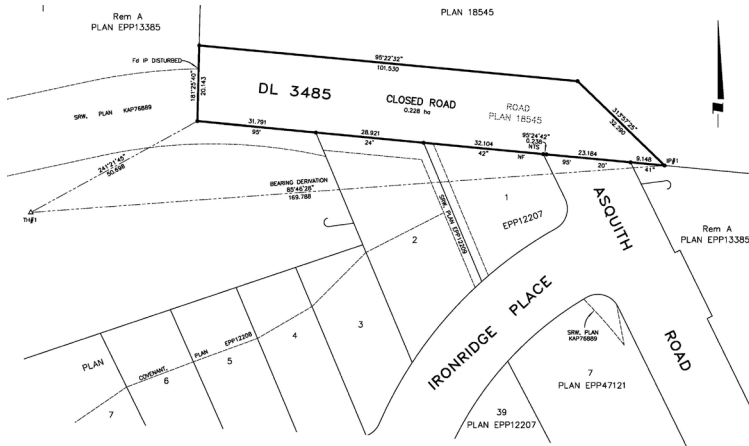
The City of West Kelowna gives notice, under s. 40 of the Community Charter, of its intention to close a portion of highway dedication to traffic a 2280m<sup>2</sup> portion of highway known as Asquith Road, dedicated as highway by Plan EPP122050, shown outlined in black on the survey plan below, and remove the dedication of that portion of the highway.

Road Closure and Disposition Bylaw No. 299, 2022 closing that portion of highway to traffic, removing its dedication as highway, and disposing of that portion of highway comprising of a 2280m<sup>2</sup> area, will be considered by Council for adoption on Tuesday, Jan. 10, 2023, at 1:30 p.m. in the West Kelowna Council Chambers.

Persons who consider they are affected by the bylaw will be provided an opportunity to make representations to Council at the meeting or provide a written submission for Council consideration.

### NOTICE OF PROPOSED AMENDMENT TO BUSINESS LICENSING AND REGULATIONS BYLAW

West Kelowna Council will consider the following bylaw amendments to the Business Licensing and Regulations Bylaw and the Fees and Charges Bylaw.

The City of West Kelowna Business Licensing and Regulations Amendment Bylaw No. 0087.16, 2010 and City of West Kelowna Fees and Charges Amendment Bylaw No. 0028.74. The purpose of these bylaw amendments are to remove the requirement for a business licence for secondary suites and carriage houses, including the fee for a business licence.

Comments regarding the proposed bylaw amendments may be made by the public during the Regular Council Meeting to be held on Tuesday, Jan. 10, 2023, at 1 p.m. in Council Chambers of the City of West Kelowna Municipal Hall, 2760 Cameron Road, West Kelowna, BC.
