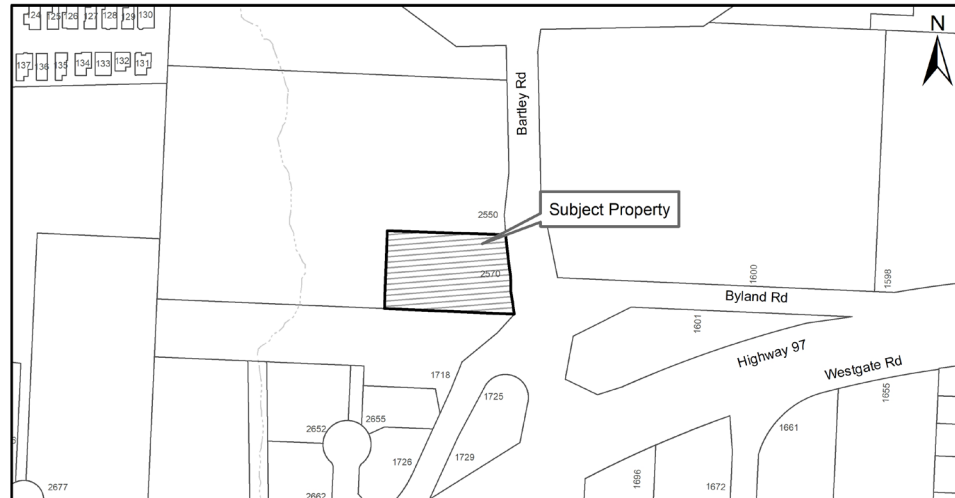
## PUBLIC NOTICE

The consideration to be received by the City of West Kelowna for the sale will be \$3,700,000.00.

The title transfer is proposed to take effect Oct. 31, 2023, upon completion of all necessary documents.
