



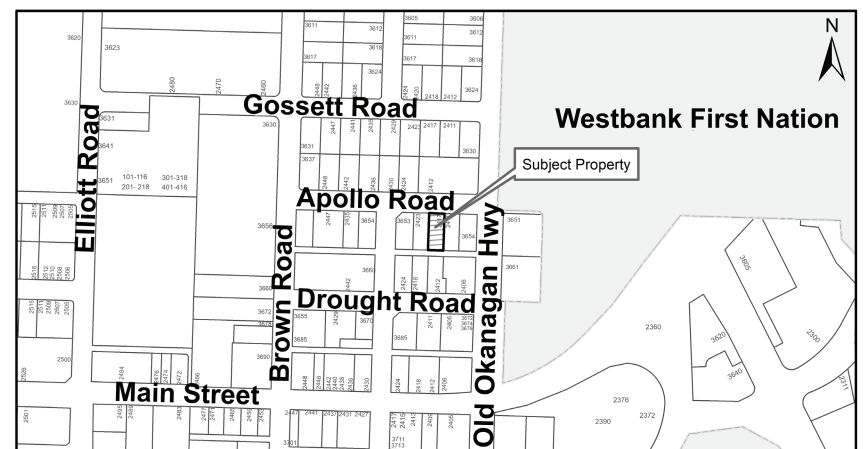
NOTICE OF PUBLIC HEARING

Location: 2417 Apollo Road, West Kelowna, BC
Legal Description: Lot 3, Block 2, DL 486, ODYD, Plan 761
File No: Z 20-02
Purpose: To rezone from Single Detached Residential (R1) to Urban Centre Commercial (C1). The C1 Zone has the potential to accommodate a variety of commercial and/or residential uses.

All submissions must be made **Attn: City Clerk, File Number (Z 20-02), include your name and address** and be submitted by 4:00 p.m. Monday August 24, 2020. Written submissions received before 10:00 a.m. August 19, 2020 will be included in the Council Agenda package. Written submissions received after 10:00 a.m. August 19, 2020 and before 4:00 p.m. Monday, August 24, 2020, will be included as a Late Agenda Item. All submissions received before the close of the Public Hearing are provided to Council.

Attend in Person

If required, the City is providing an option to attend the Public Hearing in person in accordance with physical distancing requirements directed by the provincial health authorities. To participate in person, please attend at the date, time and address stated on this notice and staff will provide you with further instructions to participate safely.

Please note that Council cannot receive submissions after the conclusion of the Public Hearing.
