NOTICE is hereby given that a Public Hearing will be held on **Tuesday, January 27, 2026 at 6 p.m.** in the **Council Chambers of the City of West Kelowna, 3731 Old Okanagan Highway, West Kelowna, B.C.** to consider:

OFFICIAL COMMUNITY PLAN AMENDMENT Bylaw No. 300.08, 2025

Location: Throughout the City of West Kelowna

File number: P 24-05

Purpose: The City of West Kelowna Council is considering Official Community Plan (OCP) Bylaw Amendment No. 0300.08. This amendment is proposed to comply with Bill 44 – *Housing Statutes (Residential Development) Amendment Act, 2023*, by:

- Updating the OCP to reflect recent Zoning Bylaw changes that enable Small-Scale Multi-Unit Housing (SSMUH); and
- Incorporating housing targets identified in the Interim Housing Needs Report (HNR).
