**Purpose:** The City of West Kelowna Council is considering proposed Zoning Bylaw Amendment No. 0320.15 to support the implementation of the City's Infill Housing Strategy and commitments under the Housing Accelerator Fund by reducing barriers to infill housing development. Additional amendments are also proposed to improve clarity and address implementation-related issues.
