Please return the completed Tenant Household Needs Assessment Form to the Tenant Relocation Coordinator. Completed forms will be attached to the Tenant Relocation Plan that will be reviewed by City staff.

5. Keep your contact details up to date.

It is important to make sure that Tenant Relocation Coordinator has your current contact details (email, phone number), including after you move, so they can provide you with updates on the Development Application.

By way of submission of a Development Application, the Tenant Relocation Coordinator will provide the City of West Kelowna with a copy of this form which contains information regarding your tenancy in order to assess their proposal. Please note, correspondence you have with the Tenant Relocation Coordinator which is directly related to the development application process may also be shared with the City.
